WHY THIS INFORMATION

Pursuant to EU Regulation 2016/679 (hereinafter "Regulation"), this page describes the methods of processing personal data of users who consult www.moelsrl.com (hereinafter "Site").

This information does not concern other sites, pages or online services accessible through hypertext links published on the Site but referring to resources outside the domain of the Site.

DATA PROTECTION OFFICER

The Data Controller does not need the figure of the data protection officer pursuant to art. 37 of the Regulation.

TYPES OF DATA PROCESSED

Data provided directly by the user

This category includes all personal data provided by the user on a voluntary basis (for example, by calling the telephone numbers on the Site; by sending email messages to the addresses on the Site; by sending messages through the information request form on the Site; etc.).

Cookies and other tracking systems

The site does not use cookies or other tracking systems.

AIMS AND LEGAL BASES

Data provided directly by the user

The personal data provided by the user in an optional way are used only to process any requests made and to comply with legal obligations and/ or pre-contractual obligations and/ or contractual obligations arising from the relationship that the user should establish with the Holder. The legal bases for the processing of such data are therefore: the fulfilment of obligations arising from the contractual and pre-contractual relationship. If necessary, the data may also be used for the legitimate interest of the owner to carry out defensive activities or to assert or defend a right in court.

METHODS OF PROCESSING PERSONAL DATA

The collected data are processed with computer tools and only in a residual way with paper mode. For the processing of data related to the services of the Site, the Data Controller uses servers located within the European territory and computer systems located at the headquarters of the Data Controller. Their transfer abroad is not planned. Technical and organisational measures shall be taken to ensure an adequate level of security and prevent data loss, unlawful or incorrect use and unauthorised access. The data provided directly by the data subject are kept for the time strictly necessary to process the requests of the data subject and then deleted, except in cases of purchase of products (against which data can be kept for the duration of the relationship and according to legal obligations) and for defensive needs (which may require further storage).

The navigation data do not persist for more than seven days and are deleted immediately after their aggregation, subject to any need for detection of crimes by the judicial authority.

NATURE OF THE PROVISION OF PERSONAL DATA

Except for navigation data, necessary to implement computer and telematic protocols, the provision of data by users through the methods made available within the Site is free and optional. However, failure to provide the data will make it impossible for the Data Controller to proceed with the requests submitted or that the user intends to submit.

RECIPIENTS OF THE DATA

The Data may be processed by employees or collaborators expressly designated "authorized to process" and/or appointed "data processors". The complete list of responsible parties is available at the offices of the Holder. The Data will not be transferred to third countries or disseminated in any way.

RIGHTS OF DATA SUBJECTS

Data subjects have the right to obtain from the Data Controller, in the cases provided, access to personal data and the rectification or cancellation of the same or the limitation of the processing concerning them or to oppose the processing and portability of data (Art. 15 et seq. of the Rules of Procedure).

RIGHT TO COMPLAIN

Data subjects who believe that the processing of personal data related to them carried out through this Site occurs in violation of the provisions of the Regulation have the right to lodge a complaint with the Guarantor, as provided by art. 77 of the same Regulation, or to appeal to the appropriate courts (art. 79 of the Regulation).
