PURPOSE OF THE PROCESSING

PROCESSING OF PERSONAL DATA

The collected data are processed with computer tools and only in a residual way with paper mode.

The Data Controller, to offer the services referred to in this Website, uses servers located within the European territory and computer systems located at its headquarters. Personal data will not be transferred to non-EU countries.

Appropriate technical and organisational measures shall be taken to ensure an appropriate level of security and prevent data loss, unlawful or incorrect use and unauthorised access.

The data provided directly by the data subject are stored for the time necessary to achieve the purpose.

RECIPIENTS OF THE DATA
